



Referral Fees, Commissions & Third-Party Services

Financial Services

Christies/Centro Residential Sales and Lettings recommends AWS Financial Services Ltd, trading as AWS Private Finance, for mortgage and financial services.

Where a client introduced by us subsequently completes a transaction, we may receive an introducer's commission equivalent to 25% of the procurement fee received by AWS Private Finance.

A procurement fee (or "proc fee") is a commission paid by a lender to a mortgage broker or intermediary following successful completion of a mortgage. There is no additional fee charged to the client by Christies/Centro for the introduction.

Legal & Conveyancing Services

Christies/Centro Residential Sales and Lettings recommends Taylor Rose for conveyancing and property-related legal services.

Where a client introduced by us instructs Taylor Rose and the relevant transaction completes, we receive a referral fee of £250 per completed transaction.

You are under no obligation to use Taylor Rose and are free to instruct a solicitor or conveyancer of your choice.

Deposit Replacement Services

Utility & Insurance Services

Where a product or service is taken following our introduction, we may receive a referral fee or commission from the relevant provider. The amount received varies depending on the provider and product or service selected.

There is no obligation to purchase any optional utility or insurance product introduced or recommended by us.

Contractors, Maintenance & Property Services

As part of our lettings and property management services, Centro Residential Lettings may recommend, introduce or instruct contractors to undertake maintenance, repairs or other works.

Where works are undertaken by certain contractors introduced or instructed through Centro Residential Lettings, we may receive a commission equivalent to 12% + VAT of the value of the works completed.
